Details and Rationale of the Agenda

- 1. Call to Order. The Chairman of the Board of Trustees and President of KCCDFI MBA, Ms. Mary Ann R. Candoy, will call the meeting to order.
- 2. Proof of Notice of the Meeting. The Corporate Secretary, Ms. Hermie A. Hasan, will certify that copies of this Notice were published through KCCDFI MBA website, Facebook page and through an advisory served to the members through the KCCDMFI Branches.
- 3. Determination of Presence of Quorum. The Corporate Secretary, Ms. Hermie A. Hasan, will determine the number of attendees, whether in person or by proxy for the purpose of determining the presence of quorum to validly transact business. A simple majority (50%+1) of the voting membership will constitute a quorum (14th Annual General Membership Meeting).
- **4. Approval of the Agenda.** The President of the Board of Trustees will present the agenda for the 2023 Annual General Membership Meeting.
- 5. Reading and Approval of the Minutes of the 2022 Annual General Membership Meeting (13th Annual General Membership Meeting) held on October 14, 2022.  - b. Nomination and Selection Procedures
 - The guidelines of the election process, as provided under the by-laws will be presented and discussed.
 - c. Election of the Board of Trustees
 - The present Board of Trustees, Nominees, and Selected Representatives will elect two (2) members of the board from the nominees to replace the outgoing members of the board whose term of office will expire. The manner of election will be through secret balloting and will be supervised by the Nomination Committee.
- **12. Appointment of External Auditor.** Upon recommendation of the Audit Committee, The Chairperson, Ms. Nevilyn P. Abualas will be going to ask the Members to approve the appointment of the External Auditor.

"RESOLVED, that Quilab and Garsuta, CPAs', be as they are hereby reappointed as external auditor of KCCDFI Mutual Benefit Association, Inc., for the year 2022-2023 for a remuneration to be approved by the Board."
